The attached DUII Statistical Report is part of OLCC's Information and Alcohol Related Crash Program. Its purpose is to provide information for the early intervention by OLCC to reduce the problems of sale or service of alcohol to visibly intoxicated persons (VIPs). The goals of the program are to identify premises that may be over serving alcohol to patrons; to provide early intervention for possible over service; to reduce over service through notification, education and enforcement; and to work with licensees where we've established over service patterns.

Because DUII reports originate from traffic stops of intoxicated persons, they are in most cases unsubstantiated information. Therefore, the report is not intended to impose sanctions on licensees, but is used to gain compliance in the area of over service through means stated above and found in the agency's Inspector Compliance Manual.
